The ALAMO MUZZLE LOADING GUN CLUB was formed in 1964 to further the sport of muzzleloading shooting. We are a family-oriented club and encourage all family members to participate. We have BBQ's, campouts at the range, shooting clinics, and organized, competitive shooting events. We strongly support the Second Amendment to the Constitution of the United States.

The AMLGC is affiliated with the National Muzzle Loading Rifle Association and the National Rifle Association. We own our own range near LaCoste with 25, 50, 100 yard and 200, 300 and 350 meter firing lines, as well as a pistol range with 5 to 15 yard lines. We sponsor organized, competitive shoots the first Sunday of every month (unless otherwise announced). Special shoots are held such as our Texas State Silhouette Championship, Turkey Shoots, Watermelon Shoots, "safari" shoots, .22 fun matches, and Civil War Skirmishes. We also have long range black powder cartridge silhouette shoots. The range is available to all members of the family, except on organized shoot days. Range Rules and Range Safety Rules apply at all times. Currently, our membership dues are \$125.00 for an annual family membership (e.g. everyone living under a single roof), or for renewals, plus a one-time \$25.00 initiation fee for first time members for \$150 total for new members. Entry fees for matches and regular monthly shoots vary according to the shoot, and help defray costs to maintain the range, purchase targets, etc.

We welcome those people who are truly interested in one or another form of muzzle loading, and/or blackpowder, whether it is collecting, competitive shooting, rendezvous, recreational shooting, hunting, or just a sincere interest in the weapons and equipment of our forefathers. Join us in fun, fellowship, and competitive shooting. Any person eighteen (18) years of age or older and of good character who is a member in good standing of the National Muzzle Loading Rifle Association or the National Rifle Association is eligible for membership. New members must be sponsored by a current member in good standing. Before acceptance of your application for membership, all prospective new members are required to meet some of the directors, attend a Safety Orientation class, and fill out a Lien Release Form. You will be contacted by a Board Member to set up the time of this orientation and safety class. After approval of your application and completion of the Safety class you will be issued your AMLGC membership card and gate combination. Keep your membership card in your vehicle or wallet. Should a fellow member request to see it, please retrieve it and show it to him or her. Likewise, members should feel free to request this information should any doubts arise about a user of the range facilities. Please also remember that each member may bring up to two guests, but only provided that those guests adhere to the range rules, pay a ten dollar range usage fee, and most importantly, *sign and date a lien release form* for the purposes of our range insurance and potential legal issues. Additional guests above the two-per-family-membership require *prior authorization* from the Board of Directors, which can be initiated through a phone call or email to one or another elected BoD officer.
