**Use of Range Release and Acknowledgement**

The AMLGC range will be open to members during the Covid-19 crisis on a temporary basis and will operate in accordance with the rules set forth by the various Declarations of Local Disaster issued by the Federal Government, the State of Texas and the County Judge of Medina County, particularly as it applies to private recreation facilities.

The AMLGC will operate the range under the following conditions, which by your signature below, you agree that you understand and agree to follow.

I understand and acknowledge that Covid-19 is a highly contagious disease easily spread through person to person contact.

In any public setting, contact with the Covid-19 disease is possible, even with the most stringent safety protocols in place. Usage of the AMLGC range may subject myself and my family members to exposure to the Covid-19 disease. By using the range, I accept this risk.

In order to mitigate the risk factor of catching the Covid-19 disease, I agree to faithfully follow the safety guidelines established by Medina County and the temporary range use rules set by the AMLGC.

In order for the AMLGC to operate, safety protocols must be monitored and maintained by a monitor, hereinafter called the Range Officer.

In order to access and use the range I agree to the following:

I will bring my membership card and I.D. with me to show to the Range Officer for access to the range.

I will follow the directions of the Range Officer at all times.

I will NOT bring any guests to the range during these temporary range times.

I will wear a face mask at all times.

I will maintain a social distancing of at least 6 feet at all times, including among people who may be in my group, except for members of the same household. I understand social distancing must be maintained while shooting, setting targets, or at any other time.

I will not gather in groups of more than 5 people at any time.

I will use only target frames provided by the AMLGC or my own target frames that fit AMLGC target holders, in order to expedite the posting of targets and due to limited shooting spaces. No other target frames will be allowed.

I will provide my own disinfectant (bleach and water, Lysol, etc.) to disinfect the loading benches and shooting benches I use while at the range.

I understand and agree that my failure to follow these rules may result in my being asked to immediately leave the range and that failure to do so may result in termination of membership after review by the Board of Directors.

I have read and agree to the above statements and have been informed of the hazard and warned about entering and remaining on the AMLGC range, I have chosen to proceed on my own free will and accept the hazard of entering and remaining on the AMLGC range.

I hereby release the AMLGC, AMLGC Board of Directors, AMLGC Officers, AMLGC Legal counsel and AMLGC Members from any all and all liabilities, illness, injuries, death, doctor's bills, hospital bills, medical bills, ambulance bills, funeral and burial costs or any other expenses incurred as a result of my entering and remaining on the AMLGC range.

I hereby acknowledge and understand the above statements and sign this Use of Range and Acknowledgement of my own choice, decision, desire and free will, without any duress or force.
