## 2023 AMLGC Range Liability Waiver

Know all persons by these presents that I,

in consideration of being allowed access to the property at, known as The Alamo Muzzle Loading Gun Club (hereinafter the AMLGC), and for use of the aforesaid premises, which may or may not include instruction in the use of firearms, and for being allowed to participate in firearms activities on or about the AMLGC, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, do by these presents for myself, my heirs, executors, administrators, and assigns, hereby release and agree not to hold liable, The AMLGC, its officers, agents and employees from any and all actions, causes of action, claims, demands, costs or damages including but not limited to: liability arising from: the discharge of firearms; the course of instruction if any; the Undersigned's participation in any course of instruction; use of the range, buildings, land and premises; the Undersigned's presence on or use of said Premises; the negligence or fault of the entities or persons released or because of their possible liability without fault; from dangerous or defective equipment or property owned, maintained, or controlled by them; for property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from the AMLGC, or any other personal injuries or death sustained by me or my property while on the property or using the AMLGC. I further agree by these presents for myself, my heirs, executors, administrators, and assigns, to indemnify, hold and save harmless the Alamo Muzzle Loading Gun Club, its agents, officers and employees, from any liability, action, claim, damage, award or judgment incurred or suffered by any entity or individual(s) as a result of any act or omission by me or caused by me while on the property, or participating in firearms related activities, or using the AMLGC for any purpose. Further, should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States or of any State, or under any theory of law or equity, the Undersigned will indemnify, hold harmless and defend The AMLGC, from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against The AMLGC, whether individually, jointly, with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

In addition, I make the following representations and acknowledgments upon which I intend The AMLGC to rely:

(1) I understand and agree that firearms will be utilized on or about the AMLGC, and that they are inherently dangerous, and I voluntarily assume all risks of using and employing firearms or other similar products and the equipment utilized in the use of those firearms, those risks being inherent in any such situation and circumstances.

- (2) I acknowledge that the activities and events conducted on the Range may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, lack of hydration; mental & physical condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, activity officials, and monitors, and/or producers of activities and events conducted on or about the property.
- (3) I certify that I am physically fit, have sufficiently prepared or trained for participation in shooting range and firearms activities, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in shooting range and firearms activities.
- (4) I acknowledge that I will not be considered an agent, servant, or employee of the AMLGC, and, thus, I will not be covered by them for any workers' compensation, medical, death or disability benefits.
- (5) I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during activities conducted on or about the AMLGC.
- (6) I understand that during activities conducted at the AMLGC, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the AMLGC.
- (7) I agree that I will not participate in any activity on or about the AMLGC, after consuming alcohol, illegal or prescription drugs or other substance that may impair my mental and physical faculties.
- (8) I understand and agree that if I am found to have violated this agreement or any policies or rules of the AMLGC as they have been explained to me, that I will be required to leave the AMLGC property, and I will have to reapply for access to qualify to be re-admitted to the AMLGC property.
- (9) This waiver and release are effective on the date signed and will remain in effect for the **2023** calendar year unless earlier revoked by me in writing.

This accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
